Question 1: With MCPS' emphasis on academic rigor, with many students, cheating on homework, projects, tests, and exams is becoming common behavior. What can the school system do to help reinforce students' academic integrity and ethical decision-making?

Cheating is becoming more and more common. In my opinion, students cheat for the same reason we have always cheated: it is easy. When examining why cheating is becoming a big problem in our county, we should remember that it is an individual choice. It is hypocritical to say that students should be able to make their own decisions regarding vending machines and driving, but not take responsibility for cheating. Students who cheat should be prepared to accept the consequences of their actions. This county can reinforce students' academic integrity and ethical decision-making by making it clear that cheating is unacceptable and that consequences will stand.

Question 2: Many MCPS schools now have resource officers roam the hallways at least once a week. Do you feel that this provides better safety within our schools? Elaborate on how you would approach making schools safer.

Making schools safer is a top priority. In recent years, security has become a pressing issue for our schools. Resource officers have done a great job of providing safety within our schools, and helping students and staff feel more secure. Safe classrooms promote a better environment for students to learn. Addressing the serious problems that affect our community like gang violence, teen drinking and drug use, and reckless driving, will help us reach our goal of safer schools.
